

**RESOLUTION OF THE AUCKLAND TRANSPORT BOARD TO AMEND  
THE AUCKLAND TRANSPORT SPEED LIMITS AMENDMENT BYLAW 2022**

Pursuant to section 156(2) of the Local Government Act 2002 the Auckland Transport Board of Directors resolves to correct errors in, and make minor changes to, the Auckland Transport Speed Limits Amendment Bylaw 2022 (“**the Amendment Bylaw**”) by amending it as set out below.

This amendment shall come into force on [2 weeks after date of Board meeting].

1. Clause 3(1) of the Amendment Bylaw is amended by inserting a commencement date as follows:  
“This bylaw comes into force on 30 June 2022.”
2. To correct an error where Buckland Road, Buckland was inadvertently included in both Schedule 2 and Schedule 3 of the Amendment Bylaw, the entry below is deleted from section 2 of Schedule 2 of the Amendment Bylaw :
