Dominion Road Corridor Upgrade

Recommendations

That the Board:

- i. Receives the report.
- ii. Approves the increase to the project budget from \$58.5m to \$66.3m (refer table 1).
- iii. Gives approval to proceed to tender for construction of the Dominion Road Upgrade Project (Project), subject to New Zealand Transport Agency (NZTA) funding being confirmed.
- iv. Delegates authority to the Chief Executive to award the construction contract for the Project (cycle route and main corridor), subject to a complying tender bid being received that is within the total approved budget of \$52.3m (refer table 2).

Executive summary

The Project was presented to the Board in March 2014 at which time the Board gave direction towards finalisation of the detailed design including the management reccomendations for; amenity improvements, safety improvements and integration of Neighbourhood Bus Interchange and Canopy Trimming PT projects.

The Project Team have finalised the detailed design and associated cost estimate taking into account direction provided at the March Board meeting and public open days held in early April. The final changes incorporated are in line with the March Board Update paper.

Strategic context

The Integrated Transport Programme (ITP) has identified Dominion Road as a key strategic transport corridor vital for the public transport network as a Frequent Transit Network (FTN) link and to reduce conflict between buses and the increased general and commercial traffic serving the growing adjacent land uses signalled by the Auckland Plan.

The forecast above includes suggested safety, cycle route and amenity enhancement items discussed in the March 2014 Board paper. Savings in the main corridor works have led to a reduction of \$1.4m from the cost forecast included in the March 2014 Board paper (\$67.7m).

The table above does not include the NBI's or canopy trimming projects (which will be funded from the existing PT capital budget).

PT Project Integration (Neighbourhood Bus Interchange & Canopy Trimming)

As advised in the March 2014 Board Paper the project team will integrate (as appropriate), two current PT projects into the Project, namely the NBI's and canopy trimming projects. Any canopy trimming initiatives need to accommodate double decker and/or light rail strategies.
